As well as in the case of a flu, or similar epidemic, the emergency plan could be activated in the event of a major emergency directly effecting the village, like prolonged loss of electricity, bad weather cutting off the village, loss of water supply for an extended period etc..

In updating the plan the Council would like to record details of those people in the community who would be prepared, and able, to assist in such an emergency situation. Therefore, if you have any special skills, equipment, or knowledge which could be invaluable to the community in time of emergency and would be prepared to lend assistance, then please complete the form on page 3.

Completed forms can be returned to the Clerk, at the address given below. Alternatively people can email, or telephone, the Clerk with the requested information.

The Clerk will also attempt a collection of forms on both the afternoon of Saturday 21st and Sunday 22nd March.

All information collected will be held in strictest confidence, and in accordance with all relevant laws¹.
